KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this _____ day of _____, 2020, by and between:

The **NATIONAL TELECOMMUNICATIONS COMMISSION, REGION IV-A**, with principal office at Diversion Road, Brgy. Bolbok, Batangas City, hereinafter referred to as the "**Entity**" of the one part, represented herein by its Officer-In-Charge, RIV-A, **ARNOLD P. BARCELONA**;

and

The **ANASCOMM ELECTRONICS SUPPLY CO.** with principal office at 3F 545 Florentino Torres St., Sta. Cruz, Manila herein after referred to as the "**Supplier**" of the other part, represented herein by its Sales Manager, **Ms. ROSEMARIE AGRAVANTE**.

WHEREAS the **Entity** invited Bids for delivery of One (1) lot Rapidly Deployable Communications System and has accepted a Bid by the Supplier for the supply of the abovementioned goods in the sum of **ONE MILLION SIX HUNDRED EIGHTEEN THOUSAND EIGHT HUNDRED EIGHTY-EIGHT PESOS (PHP 1,618,888.00)**, hereinafter referred to as the "**Contract Price**".





NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
 - (a) the Supplier's Bid Form and Price Schedule, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.
3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract
