KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this **DEC 06 2021** _____ day of _____, 2021,
by and between:

The **NATIONAL TELECOMMUNICATIONS COMMISSION, REGION IV-A**, with principal office at Diversion Road, Brgy. Bolbok, Batangas City, hereinafter referred to as the "**Entity**" of the one part, represented herein by its Officer-In-Charge, RIV-A, **ARNOLD P. BARCELONA**;

and

The **CAG ENTERPRISES** with principal office at 322 Encarnacion St., Brgy Camilmil, Calapan City, Oriental Mindoro herein after referred to as the "**Supplier**" of the other part, represented herein by its General Manager, **Engr. CHRISTOPHER A. GO**.

WHEREAS the **Entity** invited Quotations for delivery of Electronic Data Gathering / Governance and Electronic System with VOIP Network Project and has accepted the Quotations by the **Supplier** for the supply of the abovementioned goods in the sum of **FOUR HUNDRED THIRTY FOUR THOUSAND ONE HUNDRED EIGHTY PESOS (P 434,180.00)**, hereinafter referred to as the "**Contract Price**".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:

 - (c) Notice of Abstract – Request for Quotations (Reference Number 8086455) Failed status for second posting;
 - (d) BAC Resolution No. 001 – First posting;
 - (e) BAC Resolution No. 002 – Second posting; and
 - (f) Purchase Request.
3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.




