

# Contract Agreement

## KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT made and entered into this \_\_\_\_ day of 27 JUL 2024 2024, by and between:

The **NATIONAL TELECOMMUNICATIONS COMMISSION, REGION IV-A**, with principal office at Diversion Road, Brgy. Bolbok, Batangas City, hereinafter referred to as the "**Entity**" of the one part, represented herein by its Regional Director, **ROLANDO DS. SAN LUIS**;

and

The **GENUINE BUILDERS** with principal office at 254 Caingin St. Santo Tomas, Santa Maria, Bulacan, herein after referred to as the "**Supplier**" of the other part, represented herein by its General Manager, **ANGELITO C. JACINTO**.





WHEREAS the **Entity** Requested for Quotations for **delivery of Two (2) sets of detachable 8 layers Customized Steel Shelves** and has accepted the Quotations by the Supplier for the supply of the abovementioned goods in the sum of **ONE HUNDRED TWENTY-EIGHT THOUSAND PESOS (Php 128,000.00)** "**Contract Price**".

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - (a) Price Quotation Form (with Specifications)
  - (b) Notice of Abstract – Request for Quotation (Reference Number 10714468) Failed Status for first posting;
  - (c) BAC Resolution No. 2024-003 – First Posting;
  - (d) Notice Abstract - Request for Quotation (Reference Number 10764527) Failed Status for second posting;
  - (e) BAC Resolution No. 2024-004 – Second Posting; and
  - (f) Purchase Request.

3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
  
4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.

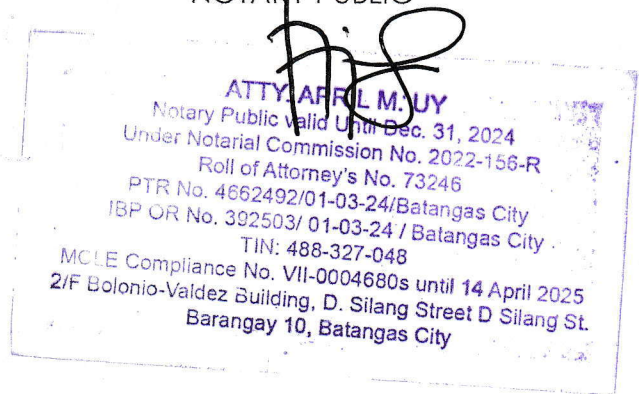
