PROCUREMENT OF ONE (1) LOT MULTIBAND NETWORK SCANNING RECEIVER AND POST PROCESSING TOOL

Issued pursuant to Sec 22.5 of the IRR of RA 9184 to clarify and/or amend certain provisions in the Bidding Documents issued for this project, considering the issues raised and clarifications made by prospective bidder during online Pre-Bid Conference held on July 29, 2020 to wit, as follows:

1. Item 8. Be able to detect different channels in a specific frequency band automatically in order to identify how many channels are used in a cell site. Suggest to add in Item 8: By only using the scanner (with antenna) and software and without the use of external tools like mobile phone	Under Section VII. Technical Specifications, page 61: Item 8. Be able to detect different channels in a specific frequency band automatically in order to identify how many channels are used in a cell site by only using the scanner (with antenna) and software and without the use of external tools like mobile phone.
2. Item 9. Test software and scanner to have the capability to locate the position of the cell site based on a specific channel frequency and Radio Access Technology (RAT). Suggest adding on Item 9: By only using the scanner (with antenna) and software and without the use of external tools like mobile phone. Must be able to show location during measurement mode and not in post processing	Under Section VII. Technical Specifications, page 61: Item 9. Test software and scanner to have the capability to locate the position of the cell site based on a specific channel frequency and Radio Access Technology (RAT) by using the scanner (with antenna) and software and without the use of external tools like mobile phone. Must be able to show location during measurement mode and not in post processing, meaning must be shown and can be saved.
3. Extend delivery period from 60 days to 90 days – For Section VI - Schedule of Requirements (This is the standard delivery for the scanner and SW and due to the pandemic, it will be harder to have earlier delivery).	Under Section VI. Schedule of Requirements, page 60: Delivered within Sixty (60) to Ninety (90) days upon receipt of notice to proceed

Suggest to add in Annex: Winning bidder must have local service center and be ISO17025 as a first line of support when it comes to troubleshooting or repair</p>	<p>Under "Annex A", page 68:</p> <p>Added Item q – Winning Bidder must have a local service center. ISO 17025 is not a requirement. However, during post qualification, should there be a tie between two bidders, ISO Certification will be considered as a tie breaker.</p>
<p>5. Clarification: Should the winning bidder still issue a retention bond even if they issued a bank guarantee beforehand? Because during bid, a bid securing declaration is already given and once awarded, a Bank Guarantee is also given. Once the items are delivered, the item will have 3 years warranty automatically and a proof of warranty is given.</p>	<p>Section II. Instructions to Bidders, No. 18 – Bid Security, page 21-23:</p> <p>There is no need for the Winning Bidder to issue a retention bond since they are already required to issue Bank Guarantee.</p>

The foregoing forms an integral part of the Bidding Documents. Correspondingly, all other provisions in the Bidding Documents inconsistent by these clarifications are similarly amended or modified.
