and

WHEREAS the Entity invited Bids for delivery of ONE (1) UNIT BRAND NEW MULTI-PURPOSE VEHICLE (MPV) AND ONE (1) UNIT BRAND NEW VAN and has accepted a Bid by the Supplier for the supply of the abovementioned goods in the sum of Three Million Two Hundred Eighty Nine Thousand Six Hundred Forty Pesos Only (Php 3,289,640.00) "Contract Price".

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (a) the Supplier's Bid Form and Price Schedule, including the Technical and Financial Proposals, and all other documents/statements submitted (e.g. bidder's response to clarifications on the bid), including corrections to the bid resulting from the Procuring Entity's bid evaluation;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.







- 3. In consideration of the payments to be made by the **Entity** to the **Supplier** as hereinafter mentioned, the **Supplier** hereby covenants with the **Entity** to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The **Entity** hereby covenants to pay the **Supplier** in consideration of the provision of the goods and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract.
