RESOLUTION NO. 2024-011

(DECLARING WINNER AND RECOMMEND AWARD OF CONTRACT)

WHEREAS, the National Telecommunications Commission, Region IV-A posted the Request for Quotation for the "**Provision of Security Services for FY 2025**" with an ABC of **Nine Hundred Thousand Pesos & 00/100 only (P900,000.00)**;

WHEREAS, the Bids and Awards Committee through its Secretariat advertised the Request for Quotation on December 03 until December 10, 2024 with cut-off time at **4:00 o'clock PM** in the following;

- DBM Philippine Government Electronic Procurement System (PhilGEPS);
- NTC Region IV-A Website; and
- In a conspicuous place reserved for the purpose in the premises of the National Telecommunications Commission Region IVA;

WHEREAS, in response to the said advertisement, three (3) suppliers submitted their respective Quotations/Proposals together with other relevant documents personally and thru email. All the Quotations/Proposals were officially received by NTC RIVA BAC Secretariat within the specified deadline;

WHEREAS, the Bids and Awards Committee proceeded to conduct preliminary evaluation on December 11, 2024, 10:00 AM held at Lily Hall, 2nd Floor, NTC Region IVA Building, Batangas City;

WHEREAS, the financial proposals were evaluated by the Bids and Awards Committee to determine the lowest quotation. The results of the evaluation are summarized and rank as follows:

WHEREAS, after evaluation of financial proposals, the Bids and Awards Committee proceeded to examine, validate and verify the eligibility requirements and declared all suppliers as eligible.

WHEREAS, the Bids and Awards Committee then examined compliance to terms and conditions (Terms of Reference) of the suppliers, to which **CORREGIDOR VETERANOS SECURITY AGENCY, INC** with the lowest calculated quotation is found to be non-compliant / non-responsive specifically under paragraph 5 of the Terms and Conditions which provides that:

*"The Security Agency with the lowest quotation must also have an office/detachment within the Province of Batangas, which **would be inspected by the BAC to verify its existence and must be operational prior to the issuance of the Notice of Award.**"*;

WHEREAS, the office/detachment is a necessary and important component of the **Terms of Reference (TOR)** for the specific requirements of the National Telecommunications Commission Region IVA to ensure that emergencies, untoward and unforeseen events involving the safety and security of the employees, clients and properties may be addressed immediately anytime and even during wee hours, that this requirement cannot be dispensed with for all intents and purposes;

WHEREAS, in an ocular/site inspection conducted to the suppliers, **CORREGIDOR VETERANOS SECURITY AGENCY, INC** is found to be non-compliant, having no office within the Province of Batangas. Further, it failed to show their office/detachment to the team conducting inspection, nor a proper office where representatives of both parties could meet and discuss, rather the meeting took place and concluded at the parking area of its client Mt. Makiling Re-Creation Center;

WHEREAS, in addition, during actual inspection, the BAC Team were endorsed from one (1) person to another, for a total of three (3) persons who do not have any knowledge regarding the purpose of visit despite advance notice given to **CORREGIDOR VETERANOS SECURITY AGENCY, INC**;

WHEREAS, Barangay San Bartolome, Sto. Tomas City, Batangas issued a Certification attesting that **CORREGIDOR VETERANOS SECURITY AGENCY, INC** conduct business in Sto. Tomas, Batangas, but the address referred in the Certification is the address of its client Mt. Makiling Re-Creation Center;

WHEREAS, for non-compliance to one of the Terms and Conditions set forth in the Request for Quotation, **CORREGIDOR VETERANOS SECURITY AGENCY, INC** is accordingly declared, **ineligible**;

WHEREAS, the **D' GREAT STALLION SECURITY AGENCY, INC** being the second lowest, found eligible and compliant to the terms and conditions, is hereby declared as the supplier with **Lowest Responsive Quotation (LRQ)**;

NOW, THEREFORE, foregoing premises considered, we, the Bids and Awards Committee, hereby **RESOLVE** as it is hereby **RESOLVED** to recommend the following:


- a. To declare the **D' GREAT STALLION SECURITY AGENCY, INC** as the supplier with the **Lowest Responsive Quotation (LRQ)** for the procurement of "**Provision of Security Services for FY 2025**";
- b. To award the Contract for the procurement of "**Provision of Security Services for FY 2025**" to **D' GREAT STALLION SECURITY AGENCY, INC** with the amount of **Eight Hundred Twenty-Two Thousand Seven Hundred Eleven and 30/100 (P822,711.30)**;
- c. To issue corresponding Notice of Award to **D' GREAT STALLION SECURITY AGENCY, INC**; and
- d. To recommend approval of **ROLANDO DS. SAN LUIS**, Regional Director, National Telecommunications Commission Region IVA, of the foregoing findings and recommendations.
